This letter responds to your Freedom of Information Act/Privacy Act request letter dated June 29, 2018, addressed to the Drug Enforcement Administration (DEA), Freedom of Information/Privacy Act Unit, seeking access to DEA records pertaining to your client, Mr. Andrade Moreno. Your request was opened and assigned the above case number. Please include this case number in any future correspondence addressed to this office.

After reviewing your request, we conducted a search for responsive records pertaining to your client. To query for responsive records, we searched the DEA Investigative Reporting and Filing System (IRFS). IRFS is the system of records that contains all administrative, general and investigative files compiled by DEA for law enforcement purposes. As a result of our query, we are unable to locate any records responsive to your request.


For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

Your appeal must be postmarked or electronically transmitted within 90 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."
